## Conducting Funded Research

#### **Dissemination and Implementation**

\*The types and levels of compensation for advocacy involvement will vary depending on the advocacy activities being undertaken, the mechanisms for payment in place at the institutions and organizations and the logistics of the collaboration. Descriptions of compensation in this section are meant to be examples. Only some options may be appropriate for a given project and there may be additional options for compensating advocates that are not listed here.

#### Compensation ranges for entire awards:

- Involvement Level: Feedback on project and quarterly meetings (travel, time, meeting attendance):
  - Typical Compensation Range for a single advocate IDEA \$500 \$2,500;
  - o Translational Award \$1500-\$5,000
- Involvement Level: Contributing to grant writing, community-led dissemination and/or patient recruitment in addition to meetings:
  - Typical Compensation Range for a single advocate IDEA \$3,000 \$6,500;
  - o Translational Award \$6,000-\$15,000

Note: Investigators and advocates should consult with their institutions to put logistics in place for items such as honoraria, contracts, and other advocate expenses.
